Sanitary Requirements

This show will have veterinary inspection according to local regulations. All cast from other countries must have microchip and rabies vaccines and passport.

It is recommended that all cats and kitten present in this show have been vaccinated against feline enteritis, rhinotracheitis, calicivirus, and rabies (for cats from abroad). It is further recommends that cats and kitten have been tested as a negative of FeLV. All registered cats must be free of parasites, ring worm and infectious diseases. Nails cats must be cut prior to the show. Cats declawed are not allowed in the room or kitten under 4 months. Following current CFA rules, the Exhibition Management reserves the right to right to deny entry or eject any cat showing symptoms of disease, illness or parasites in order to protect the other cats in the room.

Covid requierements.

All attendees must comply with local and national regulations against the covid.

In general, an interpersonal distance will be maintained 1.5 meters in public places, with special attention to closed enclosures.

Similarly, efforts will be made to intensify hand washing with hydro-alcoholic solution or soap and water. The mandatory use of masks is maintained in any closed space for public use or open to the public.
